GS#79 is a tacky non-hardening Butyl Rubber based extruded sealant, primarily used in the joints of underground pipelines. It exhibits good adhesion to clean dry surfaces (care should be taken to assure that no oils, grease or any contaminates are on the bonding surface before application). Its structural integrity and workability allows it to easily conform to pipe joint areas.
